# FORPEC: an innovative Master program in FORest Policy and EConomics

# Background

- High forestry education and science in Russia are carried at 51 universities and 4 research institutes.
- Russian forests constitute around 22% of world forest cover.
- The Forest Code while introducing some new policy directions, is very generic in contents.

# Background

- There is a pending need for better adaptation to market economy and restructuring of the institutional framework both at the federal and at the regional level.
- Forestry curricula need to incorporate social sciences, so that graduates could be able to carry out policy and economic analyses, possess entrepreneurial skills and be able to act under conditions of market economy.

# **TEMPUS FORPEC**

- Time frame:
  - December 2007 February 2010.
- Budject: Euro 300,000
- Aim: to develop new MSc curriculum at FTA according to Bologna principles and integrating modern forest policy and economics, to be launched in September 2009.



# Main Outputs

- I0 Russian teachers involved in international teacher mobility between EU and Russian consortium members
- A new **2-year MSc curricullum** in forest policy and economics
- Intensive MSc courses held at FTA



# FORPEC – first forest-related MSc programme in Russia that:

- integrates the up-to-date knowledge of forest policy, economics and management planning into a coherent study programme, which is highly relevant for the forest sector in Russia;
- is delivered entirely in English;
- is based on modular course structure instead of the traditional semester system;
- focuses on innovative methods of pedagogy with focus on learning by student.

## Admission criteria

The main selection criteria for applicants are:

- A completed BSc degree in Forestry or Economics;
- Good knowledge of written and spoken English
- High level of motivation
- Basic knowledge in forestry and economics
  Students have to pass through exam on forestry and English text
